If any such incident comes to the notice of the authorities, action should be taken against the erring official/faculty members promptly.
- The University and colleges should ensure that no official/faculty members indulge in any kind of discrimination against any community or category of students.
- The University constituted a Committee to look into the discriminating complaints received from the SCs/STs/OBCs students/Teachers and non-teaching staff.
