2	In the event of dissolution, surplus and assets shall be given to an organization, which has similar objects and no part of the same will go directly or indirectly to anybody specified in section 13(3) of the Income Tax Act, 1961.
3	In case the trust/institution is converted into any form, merged into any other entity or dissolved in any previous year in terms of provisions of section 115TD, the applicant shall be liable to pay tax and interest in respect of accreted income within specified time as per provisions of section 115TD to 115TF of the Income Tax Act, 1961 unless the application for fresh registration under section 12AA for the said previous year is approved by the Commissioner.

RULES AND REGULATIONS

1. NAME OF THE SOCIETY

: AADITYA ABHYAS ACADEMY

2. LOCATION

D.No.2-13-15, VENKATNAGAR, KAKINADA

3. MEMBERSHIP

The membership in this Society is open to all who have completed the age of 21 years. The admission fee is Rs. 1,00,000/- Only. No one can claim membership in the society as a matter of right. Membership fee for each year is Rs. 10,000/- (Rupees Ten Thousand only). Those who desire to seek membership, in the society shall submit an application to Secretary They will be disposed off by Executive Committee of the society by majority decision either to admit or reject such applications and its decision shall be final. The membership of the society shall cease in the case of failure to pay the subscription continuously for a period of 3 years.

The membership in the Society shall cease on the

A) Death or Resignation or

B) Behaviour of any member if found detrimental to the interest of the Society

4. GENERAL BODY AND ITS FUNCTIONS:

A) To elect members to the Executive Committee.

B) To approve and adopt Income and Expenditure statement of the previous year and pass the budget for the ensuing year.

C) To approve the annual report of the Society.

D) To appoint an Auditor if necessary.

E) The General Body shall meet once in a year in the month of August.

F) To Increase/ Reduce the number of Members and to make such other changes to the constitution of the Executive Committee.

G) To Remove any Member of the Executive Committee who is involving in such acts, which are prejudicial to the interests of the Society.

5. EXECUTIVE COMMITTEE AND ITS FUNCTIONS:

a) The Executive Committee shall consist of members elected by the General Body viz., President, Vice-President, Secretary, Joint-Secretary, Treasurer and four ordinary Members totalling Nine members in all.

b) The persons who have signed on the memorandum of Association of the Society at the time of Registration will be the Executive Committee upto the First General Body

meeting

c) The Executive Committee shall be responsible for the implementation of the resolutions passed by the General Body.

d) The Executive Committee shall have power to frame rules and regulations required for the day-to-day administration.

e) To review the activities of the society.

f) To review and approve the audited statement of accounts of the Society

g) The Executive Committee shall meet Four times in a year

h) The Executive Committee will be elected for every three years by the General Body. The Executive Committee elected by General Body shall hold the office for a period of 3 years. The members of the Executive Committee who retire at the end of 3 years period are eligible for Re-election/Re-appointment.

i) Any vacancy caused in the Executive Committee shall be filled up by Co-option for the

residuary period by the President of the Executive Committee.

M. Schaleddy SIGNATURE OF THE PRESIDENT

. DUTIES OF THE OFFICE BEARERS:

1) President:

- 1) To conduct meetings as chairman of the meeting.
- 2) To approve and maintain the working of the Association.
- 3) In any case, if the President is unable to perform his duties, the Vice-President shall perform the duties of the President.
- 4) If the Vice President is not available to perform the duties, the Secretary or any Member authorised shall perform the duties of the President.
- 2) <u>Vice-President:</u> In the absence of the President, the Vice-President shall perform the functions of the President.

3) <u>Secretary</u>:

- 1) The Secretary shall receive applications from the intending Members.
- 2) He shall keep all the Books of accounts and other records regularly and properly maintained.
- 3) He shall perform all the duties as entrusted by the Executive Committee.
- 4) To perform the following:
 - a) to safeguard the properties of the society.
 - b) to prepare the annual report and submit the same to the General Body
 - c) to prepare the notices for every meeting and to send it to the concerned Members of that meeting.
 - d) to prepare the Minutes and other records.
 - 5) He is empowered to approach banks or financial institutions to meet its term loan or working capital requirements or Bank Guarantees or letters of credit for smooth running of the society and also he is empowered to borrow monies from Banks/Financial institutions / others. He can obtain loan from banks/Financial institutions/others by pledging/Hypothecating / Mortgaging/Assigning the Immovable/Movable properties and any other assets belonging to the society to secure those loans for the purpose of the society. Further the Secretary is authorized to create equitable/Registered Mortgage of properties belonging to the society for the loan borrowed/to be borrowed by the society for the purpose of society from the Banks or Financial Institutions or from others.
 - 6) He can exercise other powers, which is useful for smooth running of the society as and when requires especially in administrative matters, policy matters, and financial matters.
 - 7) To Open and operate Savings bank and any other bank accounts with any Bank/Financial institutions in the name of the Society.
 - 8) To invest the funds of the society in such manner they deem fit subject to the provisions of sec 13(1) (d) read with sec 11(5) and 13(5) of the Income tax Act 1961.

M. Sale Reday

- In the absence of the Secretary, the joint-Secretary shall Joint-Secretary: perform the functions of the Secretary.
 - At the time of purchasing the property or for taking the building on lease for entering into an agreement with Private Individuals, Joint-Secretary is authorised person to represent the society for appearing in Government Offices for Registration purpose as well as in judiciary.

Treasurer: 5)

Shall have the following powers and duties:

- a) To receive all the donations, gifts and contributions etc. made to the Society.
- b) To make payments of the amounts approved by President and Secretary.
- c) To Keep monies in Deposits with banks and Financial Institutions.
- 6) QUORUM: The quorum for the General Body should be 1/4th of the Members on roll and to the Executive committee it should be $2/3^{rd}$ s.
- 7. FUNDS: All contributions and donations colleted or accepted shall usually form general funds of the Society. The funds shall be spent only for the attainment of the objectives of the Society and no portion thereof shall be paid or transferred to any of its members directly or indirectly by any means.
- Books and Other Records: Books of accounts and other Records maintained by the Secretary shall be kept at the Registered Office of the Society and shall be made available to the members for Verification during Office hours.

AMEMDMENTS: 2.

- a) No amendment or alteration shall be made in the memorandum of Association unless it is voted by 2/3rd s of the members present at Executive body meeting convened for the purpose.
- b) No amendment shall be made which is repugnant to section 2(15), Sections 11 to 13 of the Income Tax act 1961. All amendments should be made with the prior approval of the jurisdictional and concerned Income tax Authority as may be stipulated from time to time by the Income Tax Act 1961.
- 10. WINDING UP: In case the Society has to be wound up, it shall be governed by Sections 24 to 25 of the A.P. Societies Registration Act, 2001 (A.P.Act 35/2001) and the property/fund of the Society shall be transferred or paid to some other institution/trust/society having similar aims and objectives and which is having the 12A Registration under Income Tax act and as voted by the General Body.
- 11) There is no commercial or business motive in forming the Society.
