- 1. The approval accorded for the course(s) as mentioned in the table is only for 2018-19 and 2019-20 academic years and hence the College shall approach the Council for renewal of approval in 2020-21, if the college is in leased
- The Competent Authority i.e. APSCHE shall conduct inspections at any point of time.

- The management shall follow the rules issued by the Government from time to time with regard to reservations in respect of admission of students.
