This has reference to the proposal submitted by Aditya Degree College For Women, Kakinada, Andhra Pradesh for conferment of autonomous status.

The Commission in its meeting held on 25,06,2024 has approved the recommendation of the Standing Committee on Autonomous Colleges to confer the autonomous status to Aditya Degree College For Women Kakinada, Road No:5, Sambamurthy Nagar, Kakinada, affiliated to Adikavi Nannaya University, Rajamahendravaram-533296, Andhra Pradesh for a period of 10 years from the academic 2024-2025 to 2033-2034 as per clause 7.5 of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023.

The University, is therefore, requested to issue necessary notification within 30 days regarding the grant of autonomous status to the College as per above mentioned UGC Regulations of Autonomous Colleges, 2023.

The autonomous college is required to abide by all the provisions of the UGC Regulations for Autonomous Colleges. The Regulations are available on the UGC website, www.ugc.gov.in. Non-compliance of the requirements and conditions prescribed in the said Regulations shall attract action as per Clause -13 of the UGC Regulations, 2023. The college shall apply to University Grants Commission for extension of autonomous status at least three months before the completion of the period of autonomy.

Noncompliance of the above shall attract action as per Clause -13 of the UGC Regulations 2023.
 - (iii) The College/Institute is advised to take the necessary steps to implement NEP 2020 and inform the UGC.
