- 10. Both the parties may terminate this MoU with the notice period of one month. In this context, both the parties have to discharge their obligation.

VALIDITY

This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period, the Second Part.

It is expressly agreed that First Party and Second Party are acting under this MoU as independent contractors, and the relationship established under this MoU shall not be construed as a partnership.
