CLAUSE 1: CO-OPERATION

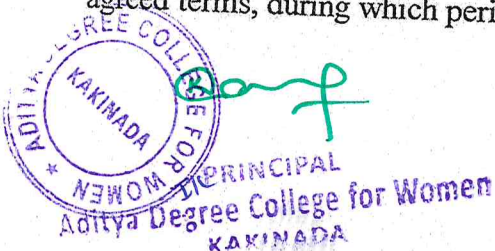
- 1.1 Both Parties are united by common interests and objectives, and they shall establish co-operation.


CLAUSE 4: RELATIONSHIP BETWEEN THE PARTIES




