CLAUSE 2: SCOPE OF THE MoU

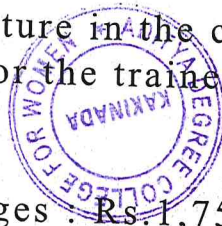
- M/s ROBOGEN, we share the common vision of empowering the students by imparting industry relevant skill sets and increasing their employability in the area of IOT & Robotics.

CLAUSE 3: VALIDITY


3.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period, the Second Party.
