This Memorandum of Understanding (MoU) is made & entered into on 11.11.2021 between Aditya Degree College for Women, Kakinada (hereinafter referred to as ADCW) Whereas ADCW is approved by APSCHE and affiliated to Adikavi Nannaya University, Rajamahendravaram and Technical Hub Private Limited, Surampalem, Kakinada, Andhra Pradesh (hereinafter referred as Technical Hub)

Purpose:

The MoU is being signed with Technical Hub as a partner to offer industry-oriented training on emerging technologies and programming languages to the students of ADCW-KKD in Computer Science, MPAIR, and Data Science specialization. This MoU between ADCW-KKD and Technical Hub will outline the services offered by Technical Hub to the students of ADCW-KKD.

Context:

ADCW-KKD is working to improve the industry-oriented coding skills of its Computer Science, Data Science, and MPAIR students, and in the process ADCW-KKD: Is exploring partnerships with different stakeholders and has identified Technical Hub as a potential partner.

As part of this MoU, both the parties hereto agree to the following respectively:

1. ADCW-KKD has approached Technical Hub and proposed to onboard them as a training partner to offer effective industry-oriented coding training in domains like (C, C++, Java, Python, .net, etc.) to its students as a measure to improve the student's technical skills and help them bag the best placement opportunities in world-renowned companies.
2. Technical Hub has considered ADCW-KKD's request and agreed to offer coding training on emerging technologies and help their students gain the right skills to meet the requirements of modern IT companies.
3. Technical Hub has agreed to offer this training at their premises in Surampalem, Kakinada
4. ADCW-KKD has agreed to make necessary arrangements to help their students reach the premises by providing appropriate transportation facilities.
5. ADCW-KKD has agreed to pay a sum of Rs.5,000/- (Rupees Five Thousand only) per student for the entire training program including the owl coder program.
6. Technical Hub has agreed to conduct periodical assessment tests to analyze the participant's performance in the program.

7. Upon completion of the training program by Technical Hub, ADCW-KKD will request third-party agent to test the student's knowledge and analyze their coding skills.

8. Based on the performance report of each student provided by the third-party agent, ADCW-KKD will release the agreed-upon sum (Rupees 5,000 per student) to Technical Hub.

9. Technical Hub has agreed to help the students who do not meet the required benchmarks in the assessment conducted by the third-party agent by offering additional training to them.

CLAUSE 3: VALIDITY


3.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms.


