4) ADITYA DEGREE COLLEGE FOR WOMEN, KAKINADA has agreed to pay the fee as below the TELANGANA VFX, ANIMATION AND GAMING ASSOCIATION for the above course.

Fee per Student – Rs. 5500/- (Including Service Tax @15%)
TELANGANA VFX, ANIMATION AND GAMING ASSOCIATION will issue a Commercial invoice with Service tax accordingly.

- 5) On payment of fee, ADITYA DEGREE COLLEGE FOR WOMEN, KAKINADA will provide the names and email IDs of students joining the course for registration in Graphics & Multimedia portal by TELANGANA VFX, ANIMATION AND GAMING ASSOCIATION. This will enable the students to have access to the Graphics & Multimedia portal, for all updates, Video lectures etc. Names and email IDs are required for conducting online exam, on completion of the course, for each student individually.
- 6) TELANGANA VFX, ANIMATION AND GAMING ASSOCIATION will complete the course in one month's time @ 2 Hrs per day; 1 hour in class room and 1 hour in computer lab daily.
- 7) 30 to 50 students make on batch for coaching. TELANGANA VFX, ANIMATION AND GAMING ASSOCIATION needs a minimum of 30 students per batch.
- 8) ADITYA DEGREE COLLEGE FOR WOMEN, KAKINADA will arrange the payment in advance and prior to commencement of classes. TELANGANA VFX, ANIMATION AND GAMING ASSOCIATION will release the courseware only the receipt of full fee.
- 9) At the end of course, TELANGANA VFX, ANIMATION AND GAMING ASSOCIATION will conduct an online exam for each student, and will issue verifiable certificates with grades and unique coding on basis marks.
- 10) Course will commence on mutually convenient date within the academic year.
- 11) ADITYA DEGREE COLLEGE FOR WOMEN, KAKINADA will provide the accommodation for Faculty in their Hostel at KAKINADA, during the course period.
