7. The staff appointed should be qualified as per the rules and regulations prescribed from time to time by the University/Government/UGC.

10. Infrastructure like Buildings, Land, Playground, Lab equipment, Library, Furniture etc., should be well maintained for the effective functioning of the College.
11. The management should not make any claim for any grant-in-aid either now or in future.
12. The College (a) should not be shifted to any other place (b) should not change the name of the College (c) should not transfer the management of the College and (d) should not convert Women's College to Co-Education and vice-versa without prior permission of the AP State Council of Higher Education/Government of Andhra Pradesh
13. The accommodation shown for the College should not be used for any other purpose other than running the college for which permission is given by the APSCHE.
14. The management should not change the Courses / Combinations, intake and media sanctioned in these proceedings without prior permission.
15. The management of the College shall set up a grievance and complaints cell as per the Supreme Court/ UGC guidelines for dealing with sexual harassment related cases & ragging and action should be initiated against erring individuals without any delay.
16. The management of the College shall not affiliate itself to any University outside the State of Andhra Pradesh and run the courses of other State University in their premises under Section 21-A of A.P. Education Act 1982, failing which, the Managements shall face criminal action under Section 21-A of AP Education Act
17. The Secretary / Correspondent of the College shall exercise powers as per the provisions of the AP Education Act 1982.
18. The management of the college shall obtain Fire Safety certificate for the college building.
19. The management of the college shall provide parking area within the premises of the college / within 100mtrs from the college building to an extent of 20% of the total built-up area.
20. A library shall be established with adequate number of titles, books and journals.
21. The Management should provide laboratories with all the necessary prescribed equipment. The college also should have an English language lab.
22. The management should establish Computer lab and procure licensed software and the prescribed hardware wherever applicable
23. The Conditions mentioned at Sl.No.17, 18, 19, 20, & 21 will have to be complied with on priority basis before affiliation.
24. The Management should maintain a website for the college and keep all the necessary academic and administrative information in the website.
25. The College concerned is not entitled to forward any recommendations for the issue of bus passes and scholarships to the students admitted into this Course.
26. If the Management either fails to fulfill any of the conditions mentioned above or violates rules/guidelines laid down by University / Government / APSCHE, issued from time to time, the permission granted will be withdrawn.
27. APSCHE / University reserves the right to conduct surprise checks at any time. And also reserves the right to cancel permission / affiliation of the college at any stage, if it is found that the documents produced by the management are false, interpolated and improper and the management is not able to run the college as per the norms of the Government and academic stipulations of the concerned University, apart from any defaults/ irregularities committed which would attract legal proceedings under General Law.

ORDER:-

The Government vide G.O under reference 3 has permitted conversion of existing programmes in colleges, regardless of they being run in leased/rented accommodation for 2021-22. The A.P State Council of Higher Education, vide reference 4 has issued circular to Managements of Private Degree College for submitting proposals for conversion of programmes.

After duly examining the proposals submitted by the institution, in exercise of the powers vested in it vide reference 1, permission accorded by the Government vide reference 3, the AP State Council of Higher Education hereby accords provisional permission to the Private Colleges whose list is appended herewith for conversion of programmes for the academic year 2021-22 under Adikavi Nannaya University area subject to the fulfillment of following conditions.

The provisional permission accorded is subject to the fulfillment of the following conditions:

1. The approval accorded for the programme(s) as mentioned in the table is only for 2021-22 academic year and hence the college shall approach the Council for renewal of approval in 2022-23, if the college is in leased premises.
2. The provisional permission is subject to fulfillment of creating classroom and laboratory facilities for the courses sanctioned. The university is requested to verify the creation of institutional and infrastructural facilities as inspection could not be conducted in view of the prevailing pandemic situation.
3. The Competent Authority i.e. APSCHE shall conduct inspections at any point of time.
4. APSCHE also has the authority to withdraw the permission, at any point of time, on any action of the Management which damages or causes disrepute to the Govt/Univ/Council.
5. The management should obtain the affiliation for the Programme, Intake and Medium of instruction, from the concerned University during this academic year only, i.e. 2021-22, failing which the permission accorded shall be cancelled without any further notice.
6. The Management should renew their affiliation each academic year by the concerned University until permanent affiliation is granted.
7. The Management shall fulfill all the requirements for starting a UG Course in accordance with (a) The rules issued by the A.P State Council of Higher Education and (b) The norms prescribed by the University committee for affiliation.
8. The staff appointed should be qualified as per the rules and regulations prescribed from time to time by the University/Government/UGC.
9. The faculty shall be recruited as per norms/Procedures, qualifications etc., as prescribed by the University/Government
10. The management shall follow the rules issued by the Government from time to time with regard to reservations in respect of admission of students.
11. Infrastructure like Buildings, Land, Playground, Lab equipment, Library, Furniture etc., should be well maintained for the effective functioning of the College.
12. The management should not make any claim for any grant-in-aid either now or in future.
13. The College (a) should not be shifted to any other place (b) should not change the name of the College (c) should not transfer the management of the College and (d) should not convert Women's College to Co-Education and vice-versa without prior permission of the AP State Council of Higher Education/Government of Andhra Pradesh
