RULES AND REGULATIONS

1. NAME OF THE ASSOCIATION : ADITYA DEGREE COLLEGE OLD STUDENTS ASSOCIATION (ADCOSA).
2. LOCATION : DOOR NO.52-7-30, CHIKKALAVARI STREET, GHATI CENTER, JAGANNAICKPUR, KAKINADA, EAST GODAVARI DISTRICT, ANDHRA PRADESH, PIN: 533002.
3. MEMBERSHIP :


The membership in this society is open to all who have completed the age of 21 years. The admission fee is Rs. 100/- only. Monthly subscription is Rs. 50/- (Rupees Fifty Rupees) for the members who are enrolled themselves as members in the Association. If any complaint is received against the Members, they shall be removed from the Association by the General Body. The membership of the Association shall cease in the case of failure to pay the subscription continuously for a period 3 months and if any behaviour of any members is found detrimental to the interest of Association, such member shall also be removed by the General Body.

4. GENERAL BODY AND ITS FUNCTIONS :

- a) To elect 09 members as Managing Committee.
- b) To approve expenditure statement of the previous year and pass the budget for the ensuing year.
- c) To approve the annual report of the Association.
- d) To appoint an Auditor if necessary.
- e) The General body shall usually meet once in a year in the month of MARCH

5. EXECUTIVE COMMITTEE AND ITS FUNCTIONS :

- a) The Executive Committee shall consists of Members elected by the General Body viz., President, Vice-President, Secretary, Joint-Secretary, Treasurer ands 04 Members totalling 09 members.
- b) The Executive Committee shall be responsible for the implementation of the resolutions passed by the General Body.
- c) The Executive Committee shall meet once in a month and review the functioning and the activities of the Association.
- d) The Executive Committee will be elected every year by the General Body.
- e) Any vacancy caused in the Executive Committee shall be filled up by Co-option for the residuary period.









6. DUTIES OF THE OFFICE BEARERS :


1. **President** : To conduct meetings as Chairman of the meeting. To approve and maintain the working of the Association. In any case, the President shall not perform his duties, the Vice-President shall perform the duties of the President. In any case the Vice-President shall not perform the duties, the Secretary or any Members shall be perform the duties of the President. *To open the bank A/c and operate bank transactions in any nationalised banks cheque power President and Secretary.*
2. **Vice-President** : In the absence of the President, the Vice-President shall perform the functions of the President.
3. **Secretary** : The Secretary shall receive application from the intending Members. He/ She shall keep all the accounts regularly and properly maintained. He/She shall perform all the duties as entrusted by the Managing Committee. He/She shall be responsible for the safeguard of the property of the Association. He/She should prepare the annual report and submit the same to the General Body. *To open the bank and operate the bank transactions in any nationalised banks cheque power Secretary.*
4. **Joint-Secretary** : In the absence of the Secretary, the Joint-Secretary shall perform the functions of the Secretary.
5. **Treasurer** : The Treasurer shall receive all the donations and contributions etc. He/ She shall spend the amount after passing receipts and maintain accounts with the permission of the President and Secretary. He/She shall open savings bank deposits and withdraw whenever necessary and spend the amount to an extent of Rs. *3000/-* (Rupees *Three thousand rupees* only) per month in the matter urgent, necessary and it should be ratified in the next General Body Meeting. In any case, for any difference in cash account the Treasurer will be responsible for the same.
7. **QUORUM** : The Quorum for the General Body should be 3/5th of the members on roll and to the Executive Committee is should be 3/5th.
8. **FUNDS** : All contributions and donations collected or accepted shall usually from General Funds of the Association. The funds shall be spend only for the attainment of the objects of the Association and portion thereof shall be paid or transferred to any of its members directly or indirectly through any means.
9. **AMENDMENTS** : No amendments or alterations shall be made in the purpose of the Association unless it is voted by 3/5th of the Members present at a meeting convened for the purpose and confirmed by 3/5th of the members agreed at the second special meeting.
10. **WINDING UP** : In case the Society has to be wound up, it shall be governed by sections 24 to 25 of the A.P. Societies Registration Act, 2001 (A.P. Act 35/2001) and that the property/ funds of the Association shall be transferred or paid to some other institution having similar aims and objects as voted by the General Body.
11. There is no Commercial motive or business in forming the Society.
