The first Party represented here in by Dr. B.E.V.L. Naidu, Principal, Aditya Degree College, Kakinada and the second party represented here in by Mr. G. Vamsi Krishna, Regional Head of FLY MASTERS, KAKINADA.

WHEREAS:

- A) First Party is an educational institutions offering degree courses at UG and PG level.
- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of their resources, and provide each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based training, Education, Expert Lecture and Career Guidance.
- D) FLY MASTERS, KAKINADA, - The Second party is engaged in Counselling, guiding for abroad education opportunities, providing training on prerequisite exams like (IELTS, TOEFL, DUOLINGO, GRE, GMAT), preparing necessary documentation for applications, Visa Documentation and Visa Interview preparation.

CLAUSE 1: CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish co-operation.
- 1.2 First party and Second party co-operation will facilitate effective utilization of the intellectual capabilities.
- 1.3 The parties shall co-operate with each other and shall as promptly as is responsibly practical, relevant agreement.

CLAUSE 2: SCOPE OF THE Agreement


