

## Memorandum of Understanding To offer industry oriented coding training

This Memorandum of Understanding (MoU) is made & entered into on 11.11.2021 between

Aditya Degree College, Kakinada (hereinafter referred as ADC) Whereas ADC is approved by APSCHE and affiliated to Adikavi Nannaya University, Rajamahendravaram and Aditya Technical HUB, Surampalem, Kakinada, Andhra Pradesh (hereinafter referred as T-HUB)

### Purpose :

The MoU is being signed with T-HUB as a partner to offer training on industry oriented coding training on latest technologies to the students of ADC in Computer Science, MPAIR and Data Science specialization. This MoU between ADC and T-HUB will outline the industry oriented coding skills on latest technologies to the students of ADC by the T-HUB coding experts.

### Context :

ADC is working to improve the industry oriented coding skills to its Computer Science, Data Science and MPAIR students and in the process ADC is exploring partnership with different stakeholders and has identified T-HUB as a potential partner.

As part of this MoU, both the parties hereto agree to the following respectively :

1. ADC has approached T-HUB to offer effective industry oriented coding training (C, C++, Java, Python, .net etc.) to its students to improve the best placement opportunities in the world renowned software MNCs.
2. T-HUB has considered ADC request and agreed to offer coding training on latest technologies to meet the requirements of IT corporate sector by their software industry oriented coding experts.
3. T-HUB is agreed to offer this training at their T-HUB premises at Surampalem, Kakinada
4. The necessary student transportation to T-HUB premises should be arranged by ADC
5. ADC agreed to pay Rs.5,000/- (Rupees Five Thousand only) per student for entire training program including owl coder program.
6. T-HUB is agreed to conduct periodical assessment tests to assess the student performance.
7. ADC will access the coding skills of its students by the third party after successful completion of training by T-HUB experts.
8. Based on the successful report of third party on each student, ADC will pay the training charges to the T-HUB.
9. T-HUB should offer additional training to the unsuccessful students identified by the third party.
10. No extra charges will pay by the ADC for additional training offered by T-HUB
11. Both the parties may terminate this MoU with the notice period of one month. In this context, both the parties have to discharge their obligation.
12. This MoU is valid for one year from the date of this MoU.
13. Any other terms and conditions will be agreed both the parties on mutual understanding.
