ORDER:-

The Sri Surya Educational Society, D.No.23-13-11/6, Sajjapuram, TANUKU - 534 211, W.G. Dist. has applied for the establishment of New Private Un-Aided Degree College for the academic year 2010-2011, vide ref 2nd cited, at Tanuku Mandal, W.G. Dist.

After duly examining the reports submitted by the JIC and that of University, APSCHÉ in exercise of the powers vested in it vide ref 1st cited, hereby accords permission to Sri Surya Educational Society, D.No.23-13-11/6, Sajjapuram, TANUKU - 534 211, W.G. Dist. for starting a New Private Un-aided Degree College from the academic year 2010-2011 as per the details given below.

The permission accorded is subject to the fulfillment of the following conditions:

1. The management should obtain the approval of affiliation for the College, Courses with Combinations, Intake and Medium of instruction, from the concerned University during this academic year only, i.e. 2010-2011, failing which the permission accorded shall remain cancelled without any further notice.
2. The management should renew their affiliation each academic year by the concerned University until permanent affiliation is granted.
3. The balance of Corpus Fund, if applicable, should be deposited in two equal annual installments during June of succeeding academic years.
4. The staff appointed should be qualified as per the rules and regulations furnished from time to time by the University/Government.
5. The management shall follow the rules issued by the Government from time to time with regard to reservations in respect of admissions of students and appointment of staff.
6. Infrastructure like Buildings, Land, Play ground, Lab equipment, Library, Furniture etc., should be well maintained for the effective functioning of the College.
7. The management should not make any claim for any grant-in-aid either now or in future.
8. Without prior permission of the AP State Council of Higher Education/Government of Andhra Pradesh, the College (a) should not be shifted to any other place; (b) should not change the name of the College, (c) Should not transfer the management of the College and (d) should not convert Women's College to Co-Education and vice-versa.

9. If the management is permitted to start the College in a rented building they should construct permanent building for the College in their own land within a period of five years.
10. The accommodation shown for Degree College should not be used for any other purpose other than running the degree college for which permission is given by the APSCHE.
11. The management should not change the Courses / Combinations, intake and media sanctioned in these proceedings without prior permission.
12. The management who have started Colleges (a) for Women or (b) rural / tribal areas should acquire a minimum of 8000sq.ft. of built up area of accommodation before the beginning of the third academic year.
13. The management of the College shall set up a complaints cell as per the Supreme Court guidelines for dealing with sexual harassment related cases and action should be initiated against erring individuals without any delay.
14. The management of the College shall not affiliate itself to any University outside the State of Andhra Pradesh U/S 21-A of A.P. Education Act 1982.
15. The Secretary / Correspondent of the College is informed to exercise his powers as per the provisions of the AP Education Act 1982.
16. The College shall not make admissions into the Courses sanctioned in this proceedings until issuance of affiliation order by the concerned University.
17. The management of the college shall obtain Fire Safety certificate for the college building.
18. The management of the college shall provide parking area within the premises of the college / within 5km from the college building to an extent of 20% of the total built-up area.
19. *If the Management either fails to fulfill any of the conditions mentioned above or violates rules/guidelines laid down by University / Government / APSCHE, issued from time to time, the permission granted to start new private Un-aided Degree College will be withdrawn.*

2. APSCHE / University reserves the right to conduct surprise checks at any time. And also reserves the right to cancel permission / affiliation of the college at any stage, if it is found that the documents produced by the management are false, interpolated and improper and the management is not able to run the college as per the norms of the Government and academic stipulations of the concerned University, apart from any defaults/ irregularities committed which would attract legal proceedings under General Law.
